We are committed to protecting your personal information and your right to privacy and will only use the information that we collect about you lawfully.

This Privacy Policy is intended to give you an understanding of how and why we use the information you give us.

This Privacy Policy applies to all information collected through our website (www.soschildrensvillages.org.uk/), and any related services, sales, marketing, or events.

The type of personal information we collect

We currently collect and process the following information:

- Personal identifiers, contacts, and characteristics (e.g., name, address, email, telephone number, age or corporate affiliation).
- Details of your visit to our website, including your IP address
- Information you input on our website or provide in physical form during events.
- Records of your correspondence with us, should you have reached out.
- Financial information such as your bank or card details.
- Information indicating any relationship to another supporter.

In certain cases, we may collect sensitive personal data, such as health conditions or disabilities, where this data allows us to tailor future communications appropriately or when related to event attendance.

Your information might be received from third parties, such as fundraising platforms, operating under their own data protection and privacy policies. We advise reviewing their privacy policies to comprehend fully how they handle and may share your data.

How we get the personal information and why we have it

SOS Children's Villages UK is committed to protecting your privacy. Most of the data we collect is provided to us directly by you, however we collect personal data through various channels to enhance our services and support our charitable activities. Below is an overview of the circumstances under which we may collect your data:

 Website Visits: We use cookies to improve the performance of our website and enhance your user experience across our digital channels. This includes cookies set by SOS Children's Villages UK, such as Google Analytics, and those set by





- third parties. For more information on how we use cookies, please refer to Appendix 1.
- **Donations and Support:** We collect data when you make financial or non-financial donations, respond to our appeals, or engage with our mailings. This also extends to those who leave a legacy or gift in their will to SOS Children's Villages UK.
- **Engagement Activities:** Your data is collected if you volunteer, act as an ambassador, fundraise on our behalf, share experiences with us, or attend our events.
- Professional Services: We gather personal information through job applications, volunteering positions, services provided directly or via an agency, or consultancy services.
- Communications: Personal data is collected when you initiate contact through enquiries, correspondence (including social media), or express interest in further engagement. This includes collecting email marketing preferences via our marketing automation service provider.
- Technical Data: Information about the devices and networks you use to access our services, including IP addresses, device types, operating systems, and browser types, is collected to improve website compatibility and security.
- **Support and Feedback:** Data provided through support channels or user feedback forms is collected to improve our services and address any issues.
- **Partnership and Research:** Personal data from individuals representing partner organisations or participating in research conducted by SOS Children's Villages UK is collected to support these collaborations.
- Compliance and Health & Safety: For compliance with legal obligations, including due diligence and anti-money laundering checks, as well as health-related information for event safety and accessibility needs, we may collect necessary personal data.

In accordance with the UK General Data Protection Regulation (UK GDPR), the lawful bases for processing this information include:

- Consent, which you can withdraw at any time by contacting us on the details shown above.
- Contractual or legal obligations, such as HMRC Gift Aid obligations.
- Legitimate interest, which can include pursuing the objectives of SOS Children's Villages UK to ensure that no child grows up alone through fundraising activities such as direct marketing campaigns, emergency appeals and special events. However, legitimate interests can also include your interests, such as when you have requested information from us, and those of third parties such as our programme participants.

We will process your data for one or more of the following reasons:

- Managing donations, including Gift Aid processing.
- Maintaining our relationship with you and updating you on the impact of your support.
- Providing you with the services, activities or information you have indicated you are happy to receive or which you have asked for.
- Compliance with applicable laws and regulations, as well as requests from statutory agencies.





- Internal administrative purposes and to keep a record of your relationship with us via our Customer Relationship Management (CRM) system.
- Internal research to enhance our effectiveness.
- Marketing communications, event invitations and supporter updates.
- Information about volunteering opportunities.
- Managing your communication preferences via our Marketing Automation and CRM systems.
- Conducting appropriate due diligence on the individuals and organisations we collaborate with.
- Enhancing our website and digital channels (through the use of cookies; see Appendix 1 for more information)
- Financial transactions and record keeping (for donations and purchases) including through our CRM and Accounting systems.
- Feedback and surveys (to improve our services and engagement)
- Tailored advertising and re-marketing (using anonymised data for relevant advertisements)
- Safety and event management (including health and accessibility requirements for events)

Additionally, we periodically verify and enhance the accuracy of your data against publicly available external data sources (such as Royal Mail), improving the quality and precision of the information we currently hold about you.

As a fundraising organisation, we undertake in-house research and from time to time engage specialist agencies to gather information about you from publicly available sources, for example, Companies House, the Electoral Register, company websites, 'rich lists', social networks such as LinkedIn, political and property registers, and news archives.

We may also carry out wealth screening to fast-track the research using our trusted third-party partners. You will always have the right to opt out of this by contacting us on the details shown above. We may also carry out research using publicly available information to identify individuals who may have an affinity to our cause but with whom we are not already in touch. This may include people connected to our current major supporters, trustees, or other lead volunteers. We also use publicly available sources to carry out due diligence on donors in line with our Ethical Partnerships Policy and to meet money laundering regulations.

This research helps us to understand more about you as an individual so we can focus conversations we have with you about fundraising and volunteering in the most effective way and ensure that we provide you with an experience as a donor or potential donor which is appropriate for you.

How we store your personal information

We prioritise the secure storage of your information. SOS Children's Villages UK maintains robust safeguards for data storage.





Normally, information about you will be stored by SOS Children's Villages UK within the United Kingdom or the European Economic Area (EEA). In situations requiring data storage outside the EEA, we undertake reasonable efforts to ensure that the recipient of such data implements GDPR-compliant measures to safeguard your information.

All online payment transactions are encrypted for added security.

How long do we keep your data?

We will process and retain your data only for a reasonable and necessary period consistent with our Data Retention Policy. The duration of retention adheres to legal and regulatory guidelines. Should you withdraw your consent for us to retain your personal data, please note that we will notify you if we are unable to comply due to overriding legal obligations.

Your data protection rights

Under data protection law, you have rights including:

- Your right of access You have the right to ask us for copies of your personal information.
- Your right to rectification You can ask us to change or complete any inaccurate or incomplete personal information held about you.
- Your right to erasure You can ask us to delete your personal information where
 it is no longer necessary for us to use it, or you have withdrawn consent, or where
 we have no lawful basis for keeping it.
- Your right to restriction of processing You can ask us to restrict the personal
 information we use about you where you have asked for it to be erased or where
 you have objected to our use of it.
- Your right to object to processing You have the right to object to the processing of your personal information where we are relying on a legitimate interest (or those of a third party) and there is something about your situation which makes you want to object to processing on this ground.
- Your right to data portability You have the right to ask that we transfer the personal information that we hold about you to you or to a third party.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

Appendix 1: Cookies

What Are Cookies?

Cookies are small text files sent from a web server to your browser when you visit a website. They are stored on your device to remember your actions and preferences over time. Each cookie contains a unique identifier (a series of letters and numbers) allowing the website to recognise your browser and provide a more personalised experience.

Types of Cookies

Persistent Cookies: These cookies remain on your device until their expiry date or until you manually delete them. They reactivate each time you visit the website that created that particular cookie, enabling the site to remember your preferences and actions across multiple sessions.

Session Cookies: These cookies are temporary and expire once you close your browser. They are used to track your activity during a single session, ensuring a smoother browsing experience.

Our use of Cookies

Cookies typically do not contain information that personally identifies a user. However, we may link the personal information we store about you to the information obtained from and stored in cookies.

We use cookies on our website for various purposes, including:

- Authentication: To recognise you as you visit and navigate our site.
- **Personalisation:** To remember your preferences, such as language and customisation settings, making our website more relevant to you.





- **Security:** To protect our site and our users by enhancing security measures and detecting fraudulent activity.
- **Advertising and Retargeting:** To conduct retargeting campaigns via social media to share our news and campaigns with you.
- Analysis and Performance: To analyse how our website and services are used and how they perform, including monitoring load balancing and website speed.
- **Donation Functions:** To manage your donation and check out process for a seamless donation experience.
- **Social Media Integration:** To support social sharing functionalities and to track interactions with our content on social media platforms.
- User Experience Enhancement: To maintain user settings to ensure the best ongoing experience for users.
- Compliance and Consent: To remember your consent choices regarding cookies.

Third-Party Cookies

Our service providers, including Google Analytics, donation software and social media platforms, use cookies. These cookies may be stored on your device when you visit our website or interact with our content on social media platforms. Social media cookies may be used to personalise ads across your social media channels. For more details on Google's privacy practices, visit their privacy policy.

Managing Cookies

You can manage cookies through your web browser settings. Most browsers provide the option to refuse or accept cookies and to delete existing cookies. The procedures for managing cookies vary by browser and version. For specific instructions, refer to your browser's help documentation.
